NINETY-NINE PERCENT OF SENIORS SERVED BY JFCSNNJ WERE ABLE TO REMAIN IN THEIR HOMES. A TOTAL OF 63,581 MEALS WERE DELIVERED TO 360 HOMEBOUND SENIORS IN 2020-21.

PROGRAMMING IS OFFERED FIVE DAYS A WEEK THROUGHOUT THE ACADEMIC YEAR FOR THREE HOURS PER DAY. PROGRAMMING INCLUDES HOMEWORK ASSISTANCE, ENRICHMENT AND STRUCTURED RECREATION FOR ALL SCHOOL DISTRICTS. DUE TO SCHOOL CLOSINGS RESULTING FROM THE PANDEMIC, THESE SERVICES WERE ONLY PROVIDED TO 110 CHILDREN IN TWO SCHOOL DISTRICTS DURING THE PAST YEAR.
